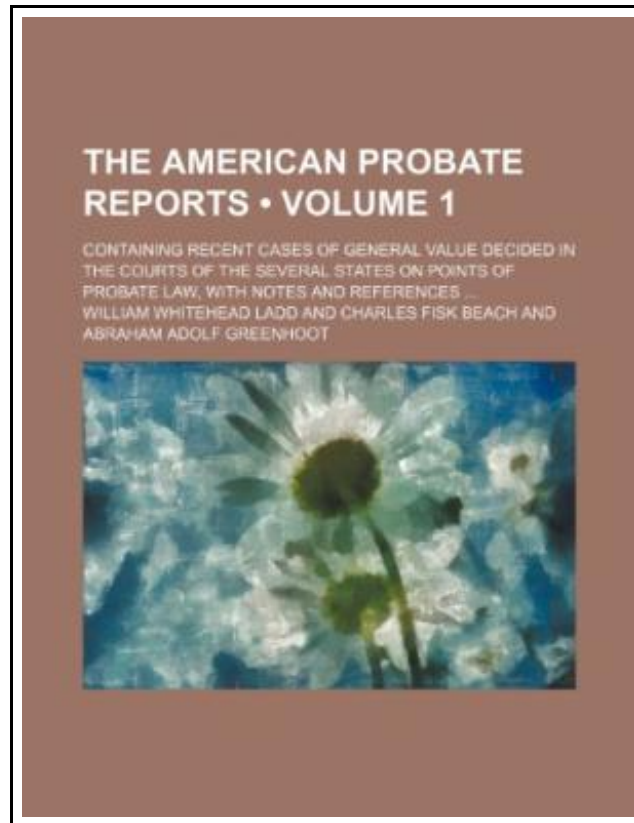

It will be necessary to examine only the defendants claim, for if that be substantiated, the plaintiffs must be without title. As to the instrument last recited, the plaintiffs contend, first, that it is not of a testamentary character. Its due execution, in accordance with the requirements of our statute, was sufficiently proved by the testimony of Annie Jacob Walsh (now Kelley), one of the subscribing witnesses. At that execution, it was declared by Mrs. Boyle to be her will. Its opening expression, In case of anything happening us, clearly indicates that it was intended to take effect only in the event of her death Roberts v. Roberts, 2 Sw. and Tr. 337; In Goods of Porter, L. R. 2 P. and D. 22; In Goods of Robinson, L. R. 2 P. and D. 171), and the rest of the instrument declares her...
